Subject: Inclusion of intervention of Shade Net House under Rainfed Area Development (RAD) component of National Mission for Sustainable Agriculture (NMSA)- reg.

This is regarding inclusion of intervention of Shade Net House under Rainfed Area Development (RAD) component of National Mission for Sustainable Agriculture (NMSA). It is to inform that with the approval of Competent Authority, the intervention of Shade Net House has been allowed under RAD as per the norms of Mission for Integrated Development of Horticulture (MIDH). Types of Shade Net Houses permitted under NMSA and its cost norms as per the MIDH Guidelines are as under:

(i) Tubular structure	Rs 710/Sqm and Rs. 816/Sqm for hilly areas. 50% of cost limited to 4000 sq. m per beneficiary.
(ii) Wooden Structure	Rs. 492/Sqm and Rs. 566/Sqm for hilly areas. 50% of cost limited to 20 units per beneficiary (each unit not to exceed 200 sq. m).
(iii) Bamboo structure	Rs. 360/Sqm and Rs. 414/Sqm for hilly areas 50% of cost limited to 20 units per beneficiary (each unit not to exceed 200 sq.m)
